#### COVID-19 and other Health and Safety Protocols

Students, staff, and any guest entering our premises or attending a Dance & Music Academy event must abide by our COVID-19 Health and Safety Protocols.

- 1. MASKS are optional for all students, staff, parents and guests. \*COVID-19 policies are subject to change at any time.
- 2. Do NOT enter our premises/event if:- You have a fever of 100.4 degrees or higher.
- You have a positive or pending test for COVID-19, if your child isn't feeling well or has any symptoms of COVID-19.
- 3. If your child or anyone in your household tests positive for COVID-19, please notify us and follow the current Department of Health Guidance.
- 4. All students must notify us of a positive test result.
- 5. All students, staff, and guests must be fever and fluid free for a minimum of 24 hours without the use of fever reducing medicine before entering the premises/event.
- 6. Dance and Music Academy will continue to notify families of a positive case in a child's class, sanitize of our facility, screen staff, provide hand sanitizer throughout the facility, and use air purifiers inside class rooms
- 7. Virtual Lessons Music students please notify the office if you would like to switch to a virtual lesson. Dance students: You can access your zoom link via your Parent Portal under each class.

### 2022-2023 Aug-May: Registration

- 1. Once registered, the student is enrolled for the entire August-May season.
- 2. Registration Fee There is a \$45 annual registration fee per family due at the time of registration. This fee is non-refundable.
- 3. To complete registration the registration fee (if applicable) and the first tuition payment are due, will be charged immediately, and are non-refundable. Any applicable discounts will be manually adjusted prior to charging your card.
- 4. In the event we are unable to hold classes in person at the studio alternate arrangements will be made. This could include but not limited to: outdoors, alternate location, or online service like Zoom. Your contract is for dance classes and/or music lessons, not the location.
- 5. Children cannot exceed more than 10 hours of instruction per week.

### 2022-2023 Aug-May: Payments and Fees

- 1. Tuition is due in 10 equal payments August-May.
- 2. Tuition is due and will be billed on the 1st of each month. Auto billing is required. This means that you must leave a card on file. If you are unable to leave a card on file, you must pay a month's tuition as a deposit. This deposit will be placed in your account to cover late fees, returned check fees, and unpaid costume fees. Any balance of the deposit left over at the end of the year will be posted to the last month's
- 3. Any account unpaid after the 5th of the month, including declined auto drafts, will be assessed a \$15 late fee. There will be a \$25 fee charged for checks returned due to insufficient funds.
- 4. We do not send out monthly invoices. - 5. Tuition for dance is based on an annual fee divided into 10 equal payments. Monthly tuition does not change based on the number of classes in a particular month. No refunds or credits will be given for unattended classes. Please refer to the make up policy for missed
- 6. Dance tuition prices now include individual dance portraits for all regular classes and digital downloads of recital performances. Company tuition includes individual dance portraits for 2 costumes as well as the digital downloads of recital performances.
- 7. The following fees are nonrefundable: Registration Fee, First Tuition Payment, Costume Fee (once the order has been placed), and Recital
- 8. Costume Fees for dancers participating in the Spring Recital will be split evenly and due with October and November tuition. Pre K-Primary costumes are \$80 and Junior-Teen costumes are \$90. Any costumes that are not paid in full by November 5th will incur an additional \$15 shipping fee. Please see Company and Competition packets for specific costume pricing
- 9. There is not a recital fee, but you will need to purchase recital tickets.
- 10. Non recital classes will not have class during photo week or the week of dress rehearsal.
- 11. For advanced track dancers: the Star Fee, Company Fee, Company Tuition, and any Competition Fees are non-refundable.

## 2022-2023 Aug-May: Spring Performances

- 1. Our recitals for dance students and music students will be separate events. Participation in the Spring Recital is encouraged, but not mandatory
- 2. The Spring Dance Recital will be held on Friday May 5th Sunday, May 7th, 2023. Dress rehearsal for the Spring Dance Recital is mandatorv and will be held at the Roswell Cultural Arts Center Monday May 1st - Friday May 5th, 2023.
- 3. The Spring Music Recital date is TBD. There will be no Dress Rehearsal for the Spring Music Recital. Music students may be placed in small groups. Music students of all levels are eligible to participate in the Spring Music Recital (if enrolled by January 15th, 2023).

## 2022-2023 Aug-May: Make Ups and Cancellations

- 1. Make ups for Music Students Music students may only make up (1) absence per semester (Fall: August-December, Spring: January-May) 2. Make ups for Dance Classes If you miss a lesson during the months of August - February you may make it up in any other similar level
- class. Make ups will not be permitted starting in March as each class will be rehearsing heavily for their particular recital dance.
- 3. Teacher cancellations: Any lessons cancelled by the teacher will be rescheduled
- 4. Weather related closings: We will send out emails for any closings due to weather. Dancers may make up missed lessons in any other similar level class. Music students will have their missed lesson rescheduled by their instructor. Lessons may transition to a digital format due to weather related closings.

# 2022-2023 Aug-May: Withdrawal

We hate to see you go, but if you need to withdraw for any reason you are required to give 30 days notice via Dance and Music Academy's Withdrawal Form (forms can be picked up at the office or online under 'Parent Info'). I understand that it will not be sufficient notice to merely tell an instructor or supervisor, leave a voice-mail, or send an e-mail of my intent to discontinue. You are responsible for tuition and any late fees during the 30 day notification period. If the withdrawal form is not submitted, you will continue to be billed and are responsible for tuition and late fees. This 30 day notice does not apply to Company and Competition dancers. They are bound to the terms of their Company and/or Competition contracts. Please refer to those contracts for further details.

## Children Group Care License Exemption
